## Scheme of Arrangement becomes effective

Further to its announcement on 17 April 2023, OZ Minerals is pleased to announce that it has today lodged with the Australian Securities and Investments Commission ("ASIC") a copy of the orders of the Federal Court of Australia ("Orders") approving the scheme of arrangement pursuant to which BHP Lonsdale Investments Pty Ltd, a wholly owned subsidiary of BHP Group Limited (ASX: BHP), will acquire 100% of the shares in OZ Minerals ("Scheme").

### Lodgment of Court Orders and Suspension of Trading

A copy of the Orders lodged with ASIC is annexed to this announcement as Annexure A.

The Scheme is now legally effective, and it is expected that OZ Minerals shares will be suspended from trading on ASX from the close of trading today, 18 April 2023.

### Payment of Scheme Consideration and Special Dividend

As announced by OZ Minerals on 13 April 2023, OZ Minerals has declared a fully franked special dividend of \$1.75 per OZ Minerals Share ("Special Dividend").

Accordingly, OZ Minerals Shareholders ("OZ Minerals Shareholders") will be paid on the Implementation Date (Tuesday 2 May 2023):

- \$1.75 for each OZ Minerals share they hold on the Special Dividend Record Date (being 7.00pm (Melbourne time) on Friday, 21 April 2023); and
- \$26.50 for each OZ Minerals share they hold on the Scheme Record Date (being 7.00pm (Melbourne time) on Monday, 24 April 2023).

Certain OZ Minerals shareholders may be able to realise the benefit of \$0.75 franking credits per OZ Minerals share that will be attached to the fully franked Special Dividend. The franking credits you may be able to utilise from the Special Dividend will depend in part on your own personal circumstances in respect of which we encourage you to seek independent legal and taxation advice. Refer to the Scheme Booklet released to the ASX on 3 March 2023 for further information.
